Author Guidelines

1. Authors are required to get registered via Open Journal System prior to submission of manuscript.
2. **Critical Review of Social Sciences and Humanities (CRSSH)** considers only those research manuscripts which are submitted via Open Journal System (OJS) to www.crssh.com
3. It is author(s)' responsibility to ensure that the manuscript has neither been published nor submitted somewhere else for publication either in parts or as a whole.
4. Once the manuscript is received online (OJS), the desk editors will filter the manuscript in the light of Author-Guidelines. Based on the desk review, the manuscript is either sent back to the author(s) for further modifications or sent for the blind peer review.

5. Please download the Article submission template and manage your article accordingly. Dear author your article will not be processed without the suggested formatting.
6. Manuscripts must be formatted according to the latest edition of APA (American Psychological Association). While writing a research paper for CRSSH, the observance of the following is a must:
 - A. APA suggests font = Times New Roman; Font-Size =12; Line-Spacing =1.15; Margins=1 Inch – All Sides
 - B. The word count of the research article would range between 4000 to 6000.
 - C. The title page should include an informative title, author's name, and complete mailing address including Postal & Online – email, Telephone & Fax No.
 - D. **Abstract:** The abstract consists of the statement of the problem, research design, major findings and conclusions (Maximum words: 150). Maximum key words are five.
 - E. **Main-Body:** The text should be divided into sections with the following headings:
 - I. **Introduction:** In this section, the rationale of the present research along with its background and the clear mention of the objectives is discussed.
 - II. **Literature Review:** To explore the untapped research gap in the area for the present researcher, previous relevant research projects are reviewed here.
 - III. **Research Questions:** Research statement along with research questions are discussed in this section of the research paper.
 - IV. **Research Design:** Theoretical/conceptual framework plus the type/nature of research are satisfactorily elaborated here.
 - V. **Data Analysis:** The selected narrative will be analyzed in the light of the well framed research questions.
 - VI. **Findings and Recommendations:** Present the results of the research in a systematic and logical way. For this purpose, help can be sought from tables, figures and diagrams.
 - VII. **Conclusion:** Interpret results and relate them with existing knowledge relating to the methods and results of the respective area of research.

Submission Preparation Checklist

Before submission of your manuscript, please check that:

1. The submission has not been previously published, nor is it before another journal for consideration (or an explanation has been provided in Comments to the Editor).
2. The submission file is in OpenOffice, Microsoft Word, or RTF document file format
3. Where available, URLs for the references have been provided
4. The text is single-spaced; uses a 12-point font; employs italics, rather than underlining (except with URL addresses); and all illustrations, figures, and tables are placed within the text at the appropriate points, rather than at the end
5. The text adheres to the stylistic and bibliographic requirements outlined in the Author Guidelines.
6. All references cited in the text are included in the reference section.
7. All figures and tables are cited in the text.

9. Plagiarism Reports is not more than 18% (Turnitin).
10. Does the paper fall under **Journal Scope**?
11. Does Paper have followed **Journal Template**?
12. Paper is submitted with the acceptance of Journal's Policies.

Note: In case of failure of the above checklist, the paper is desk rejected and does not process further. If a paper passes the above checklist, it will be further forward for the following review process.

PEER-REVIEW POLICY

Peer review is the evaluation of manuscripts submitted to the journal is reviewed by experts in related fields. Peer review enables authors to receive critical feedback from experts on individual manuscripts.

All submitted manuscripts are kept confidential. Reviewers are not allowed to share or disclose unpublished information in a manuscript.

Reviewers of Critical Review of Social Sciences and Humanities (CRSSH) avoid evaluating manuscripts in which they have conflicts of interest. They contact editors if there is any conflict of interest that could affect their evaluation of a manuscript. In those cases, they can reject reviewing the manuscript.

Reviewers can recommend to the author/s any related work that is not cited.

We use a double-blind system for peer review: The identities of both reviewers and authors remain anonymous. Each submitted manuscript is peer-reviewed by at least two experts. In some rare cases, we may start the third round of peer review according to the recommendations from editors and reviewers.

CRSSH observes the practice of peer review to ensure the quality of published research. The said practice is adopted by reputable research journals. Our review committee plays a pivotal role to maintain the high standard of research publication. All the manuscripts submitted to CRSSH are peer-reviewed in the following ways:

- Initial manuscript evaluation The Editor and team first evaluate all manuscripts. It is rare, but an exceptional manuscript can be accepted at this stage. Manuscripts rejected at this stage are insufficiently original, have serious scientific flaws, have poor grammar or English language, or are outside the aims and scope of the journal. Those that meet the minimum criteria are normally passed on to at least 2 experts for review.
- CRSSH employs double-blind reviewing, where both the reviewers and the authors remain anonymous throughout the process.

- How the reviewers are selected, reviewers are matched to the research article according to their expertise and our database is constantly being updated.
- Language correction is not part of the peer-review process, but referees may, if so wish, suggest corrections to the manuscript
- Reviewers are asked to evaluate the manuscript on the following basis:
 - The originality of the paper
 - Soundness of methodology
 - Adherence to the appropriate ethical guidelines
 - Clarity of results and conclusions
 - Correct representation of the references

Timeline of the review process

- The time required for the review process depends on the response of the reviewers. In case the reports of the reviewers contradict or a report is unnecessarily delayed, a further expert opinion is sought. In rare cases for which it is extremely difficult to find a second reviewer to review the manuscript, or when the one reviewer's report has thoroughly convinced the Editor, decisions at this stage to accept, reject or ask the author for a revision are made based on only one referee's report. The Editor's decision will be sent to the author with recommendations made by the referees, which usually include precise comments by the referees. Revised manuscripts might be returned to the initial referees who may then request another revision of a manuscript.
- A final decision to accept or reject the manuscript will be sent to the author along with any recommendations made by the referees and may include exact comments by the referees.
- Editor's Decision is final which is based on the reviewers' recommendation regarding the suitability of the research article.

Note for Reviewers

Those who want to act as reviewers of CRSSH may contact the editor. The benefits of refereeing for CRSSH include the opportunity to read see and evaluate the latest work in their research area at an early stage, and to contribute to the overall integrity of scientific research and its published documentation. They may also be able to cite CRSSH work as part of their professional development requirements for various professional societies and organizations

Tips for avoiding plagiarism

- Keep full record of every source of information you use including the date you accessed electronic resources,
- Place quotation marks around any words you copy verbatim and credit the source,
- Use your own words when summarizing or paraphrasing someone else's words—but don't forget—you will still need to reference it!
- Make sure you check with your Journal which referencing system they want you to use

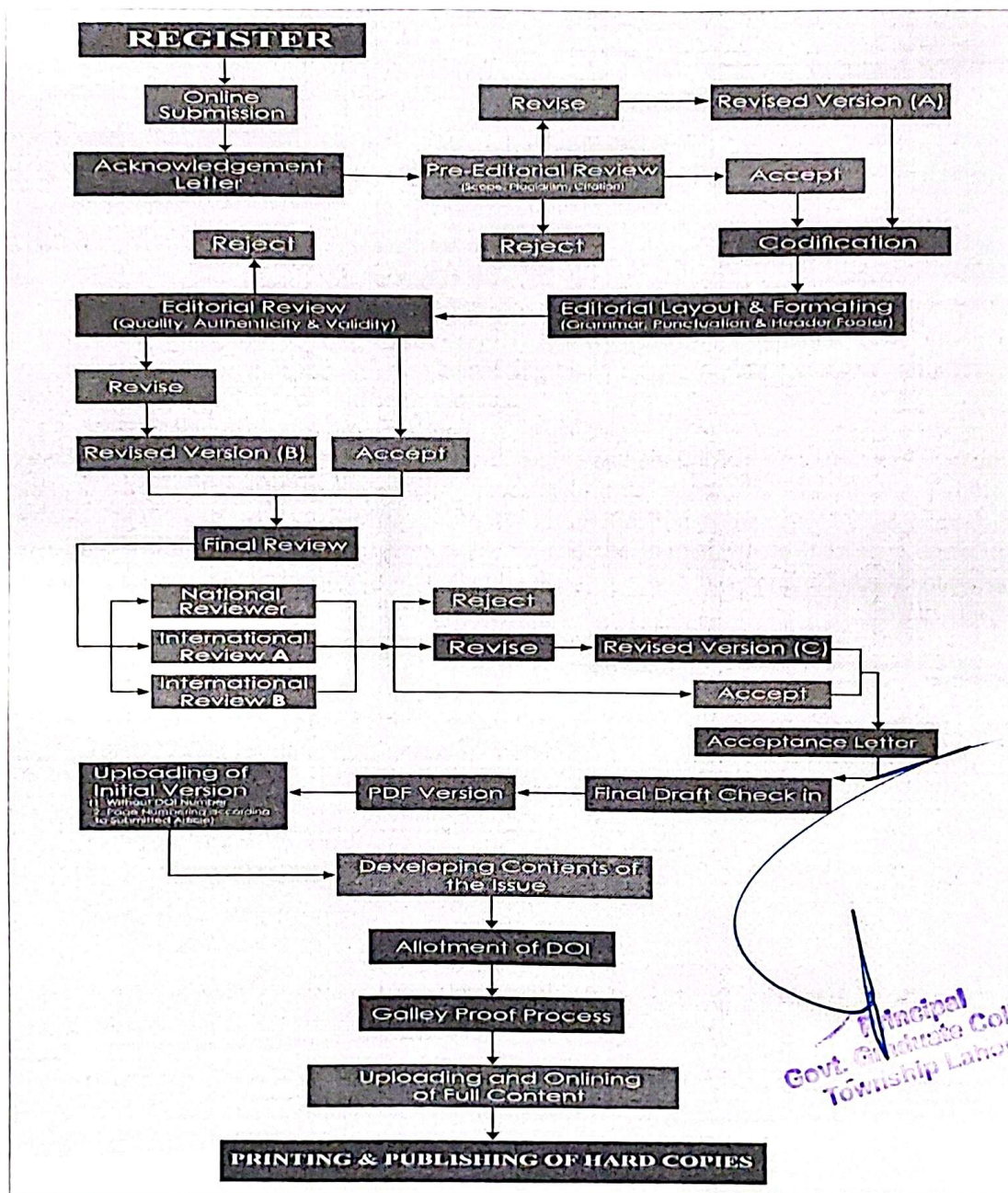

CONFLICT OF INTEREST

Disclosure and CONFLICT OF INTEREST, correction and retraction of research articles, contribution and consent of each author and any other information

When submitting a manuscript to CRSSH, *the* authors are always asked to disclose potential conflicts of interest. Ideally, conflicts of interest should be avoided, but in reality, this is not always possible.

Conflicts of interest can be financial or non-financial. Form for Disclosure of Conflicts of Interest does include both financial and non-financial relationships. Only relationships relevant to the study in the manuscript need to be declared. There is no definite cut-off as to how relevant or how much money is involved when a conflict of interest has to be reported. The authors will need to make their judgment, but if it is something that a reader might perceive as can affect the objectivity of the author, it should be disclosed.

If a conflict of interest is not disclosed in a published paper but later found out by a reader and reported to the journal, the journal usually will ask the authors to clarify whether such a claim is true and may ask the authors' institution to investigate if the research is still credible. Failure to disclose conflicts of interest generally will not lead to retraction of the paper by the journal, but the authors will need to update their disclosure and the journal would publish a correction. However, retractions may happen if journals find that the authors have omitted major conflicts of interest that are likely to influence the study.

OPEN ACCESS POLICY

CRSSH is an open-access journal which means that all content is freely available without charge to the user or his/her institution. Users are allowed to read, download, copy, distribute, print, search, or link to the full texts of the articles, or use them for any other lawful purpose, without asking prior permission from the publisher or the author.
